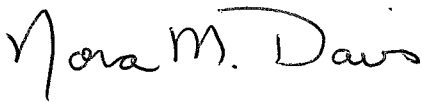
Dear Deb:

Enclosed – the petition for the City Council, to be formally presented at the City Council meeting on Tuesday, October 17, 2017.

The petition focuses on the concern of the Lake Cornelia Neighborhood (including the surrounding area) regarding the Estelle Project. This development will harm our neighborhood with a loss of sunlight and privacy, light and noise pollution. And common sense will tell you the traffic *will increase*. The project doesn't belong adjacent to a neighborhood of single family homes, and we are asking the City Council to abide by the current Comp Plan. *It's just too tall.*

This represents the neighborhood *most* affected – *not* Country Club, Interlachen or Point of France. Signatures were collected by neighborhood residents, not employees of various firms.

Adherence to Comp Plan Height Restrictions and Transition Area re: “Estelle Edina”

We, as property owners and residents of the Southdale First Addition, Lake Cornelia Neighborhood and surrounding neighborhoods, request that our City Council **adhere** to the **Comp Plan with Transition and Height Restrictions** regarding Estelle Edina.

This project does **not** belong in the 69th & France location. It is **too close** to the adjacent neighborhood – less than 200 feet in some areas. It **violates** the comp plan, which states the property is a **transitional zone** to that neighborhood, and **limits buildings to just four stories and 48 feet**.

It will do irreparable harm to that adjacent neighborhood, lacks respect for the neighborhood and the Edina residents who live there.

The intrusion into the daily lives of residents with the loss of privacy, the shadows created by that massive 360 foot tower, the light, visual and noise pollution, along with the increased traffic, makes that project unsuitable for that location.

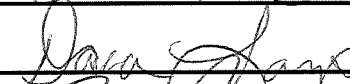
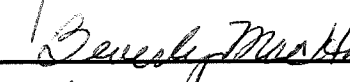
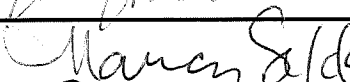
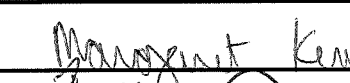
