## City of Edina Health Commission: Opioid Workgroup Information Update

April 12, 2021

The following report and city websites were reviewed by the City of Edina Health Commission Opioid Workgroup.

This information is groundwork to developing recommendations for the City of Edina to consider to address opioids misuse and overdose death increase.

The 2020 Hennepin County Opioid Response Strategic Framework was reviewed.

Deaths from opioids increased from 63 in 2007 to 129 in 2018.

From this framework, a potential area for City of Edina to address opioids is through primary prevention to reduce opioid misuse and overdose that includes safer storage and disposal of medications.

Key Resources information resources in this report include:

- Hennepin County disposal methods
- Law Enforcement actions
- Prevention of Prescription Painkiller Abuse

The workgroup reviewed the following cities websites for opioid content and found all had disposal information with different levels of detail. The City of Plymouth was a more robust website and included additional information linking to law enforcement and prevention of painkiller abuse.

Cities websites reviewed were: Edina, Plymouth, Bloomington, Eden Prairie, Golden Valley, Minnetonka and Richfield.
