ACTION REQUESTED:

Adopt Resolution No. 2023-08 Adopting the Proposed Budget and Establishing the Proposed Tax Levy Payable in 2024.

INTRODUCTION:

The HRA is a separate taxing authority formed by the City Council in 1974. The purpose of the levy is to pay a portion of the administrative expenses and other economic initiatives that are necessary to operate the HRA. The levy proposed for 2024 is \$251,700, which is a \$7,300 (three percent) increase over the 2023 HRA levy amount.

HRA adoption of this resolution is required to establish the HRA levy for 2024. Staff recommends the HRA members approve the HRA levy resolution on December 5, 2023. If no levy and budget resolutions are passed on December 5, then the Council and HRA are required by statute to act at the next meeting on December 19, 2023.
