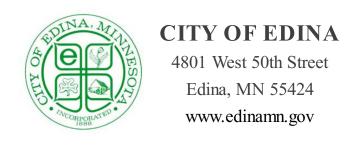

I. Call to Order

Acting Chair Cundy called the meeting to order at 7:02 p.m.

II. Roll Call

Answering roll call were Commissioners Cundy, Nickels, Pope, Breiter, Olson, Farrell-Strauss and student member Kiely. Commissioner Everson joined after Roll Call.

VII. Reports/Recommendations

A. H-21-6: 4633 Arden Avenue-Changes to Approved Garage Elevations

The existing home is classified as an American Colonial Cottage and was built in 1928. The proposed changes are to eliminate a stairway bump-out, to eliminate a window on the south elevation, eliminate a window on the east elevation, to add windows on the garage doors, add a service door on the west elevation, and to change the exterior materials on the garage. Staff recommends approval with the condition that architectural decorative elements be added to the east and south elevations. Other recommendations conditions include adding an "as built date plaque," and that any additional improvements would have to be submitted and approved.

Additional discussion ensued regarding brick v/s siding.

Motion made by Cundy, seconded Nickels, to approve the amendment to H-21-6: 4633 Arden Avenue-Changes to Approved Garage Elevation with the above noted conditions. 7 voted aye, I nay (Olson). The motion carried.

VIII. Special Recognitions and Presentations (moved from item V)

A. Consultant Led Training

The important concepts of compatibility and differentiation were discussed. Additional discussion ensued regarding ways to separate the new from the old with preservation in mind. Examples were shown. There was discussion that included lots of questions and answers regarding the examples. It was noted that preservation is an art, not a science.

A. Heritage Award

An overview was given of the Heritage Award. Each year properties are submitted on the City website, and this Commission votes and recommends the winner to City Council. Some of the Mid-Century-Modern homes were discussed. The deadline for entries is March 31, 2024. There is no action to be taken on this topic.



Reason: What was done to preserve and/or restore the historic integrity of the nominated property?*

The HouseNovel website, launched in 2022, has preserved photographs and information on more than 600 residential properties in Edina. Founders Amanda Zielike and David Decker have created a free, user-friendly platform for residents to discover and document the rich history of homes and their occupants. They created a tremendous digital preservation resource by aggregating the site with data and photos from public websites, including photos and details of more than 500 homes in the Country Club District from the 1980 National Register of Historic Places listing submission to the Department of the Interior. In addition, nearly 100 Edina homes outside of this District have photos and information preserved on HouseNovel from the Minnesota Historical Society, the Hennepin County History Museum, and the Minneapolis Star Tribune.

This national website started locally and deserves the Edina Heritage Preservation Award for three reasons: 1. Founder Amanda Zielike Founder was born and raised in Edina, living primarily on Lois Lane where her father still runs Edina Clock Repair out of the home. 2. The Edina Sun Current published the first article about HouseNovel, leading to a cascade of additional press about their work to preserve home history. 3. Amanda Zielike and David Decker have been generous partners with the Edina Heritage Preservation Commission in its development of the Century Homes Program, vetting and expanding the list of resources homeowners can use to research the history of their home. The novelty and scale of HouseNovel's preservation efforts deserve recognition — digitizing historic photos of more than 600 Edina properties and creating a tool that local residents and real estate agents are beginning to use to preserve details and stories about these homes.


