I. Call to Order

The meeting was called to order at 7:02 AM.

II. Roll Call

III. Approval of Meeting Agenda

Member Hunt moved, second by Member Brown to approve the Agenda as presented. Motion carried.

IV. Approval of Meeting Minutes from June 17, 2020

Member Hunt moved, seconded by Member Siekman to approve the minutes. Motion carried.

V. Discussion Items

a. Mapping Prejudice: Kevin Ehrman-Solberg gave a presentation on the Mapping Prejudice project at the University of Minnesota. In the past racially restrictive covenants were placed on houses. Although are not legally binding today these covenants, combined with Redlining that also occurred, promoted racial segregation. As a result over time Minneapolis became more and more segregated, with Whites almost exclusively in neighborhoods with greater than average housing prices and Blacks predominantly in neighborhoods with lower than average housing prices, as evidences by maps. Ehrman-Solberg stated that the Twin Cities has one of the worst racial disparities in homeownership and the largest wealth gap in the County. Although covenants are no longer enforced, wealth barriers reinforce racial barriers.

b. <u>Principles and Goals:</u> The Task Force reviewed the Principles and Goals where they were close on agreement to approve. They discussed how the Principle and Goal could be made more acceptable and what aspects could be discussed as a strategy. They then rescored using the "Fist to Five" methodology.
